I am directed to state that the Commission has decided that -

(a) The officers and staff of following departments will not be  
requisitioned for deployment of election duty:

- (i) Senior officers of the Indian Forest Service.
- (ii) Doctors and Compounders working in veterinary hospitals.
- (iii) Officers working in Grade - B (Cattle Extension Officer) in  
veterinary hospitals.
- (iv) Medical Practitioners
- (v) Territorial Staff of Forest Department
- (vi) All India Radio.
- (vii) Doordarshan.

The operational/technical staff of BSNL, MTNL, UPSC and  
educational institutions will be requisitioned for election duty only in  
unavoidable circumstances

(c) Officer/staff of Commercial Bank located in rural area and if happens  
to be a single officer branch, need not be deployed.

(d) It is clarified that while drawing persons for election duties, you  
should explore the possibility of asking for persons from all such
